

## EC'S CORNER

Preparations for the annual Field Day are underway. As most of you know, the event is designed to sharpen communications skills in a "field" environment such as one might find in an emergency situation. What makes it interesting and

fun is that it is done in a contesting environment, with extra points for things like reduced power, alternate power sources and availability to the public. Many individuals and groups combine Field Day with camping and outdoor activities.

This year, we're fortunate to have our trailer ready for the event. Special thanks go to club members who worked hard to modify the forward part of the vehicle as a very nice Communications Room. Ted Miller, K6FGE and Paul Sullivan, W6VPS used their skills to design, then construct the operations desk. They were assisted by Dan Pruitt, KG6ALC and Steve Miller, K6FDR. We are also grateful to those who offered valuable suggestions. There is room for two HF radios, computers and VHF/UHF equipment. Up to four operators can be on duty at the same time.

No doubt we'll see ways to improve the rest of the setup during Field Day, but for now, it will be a huge improvement over some of our past events. "Off shift" operators can take advantage of the two sleeping bunks and a fresh pot of coffee on the stove. By the way, the trailer is self contained and even has an air conditioner, microwave oven and refrigerator. What a fantastic achievement!

By the way, the 2004 Fresno Hamfest had a lot of great information on the part Amateur Radio can play in disaster communications. ARRL Rep Dan Miller, K3UFG, flew in all the way from Hartford, Connecticut to explain Emergency Communications. There was audience discussion about how to get around the word "Amateur" to describe what we do, and to eliminate a negative image impression among public officials. Miller emphasized the need to be in constant contact with said officials. Through demonstrated capabilities, he says, we can override the "rag tag" image of some radio communicators.

ARRL Pacific Division Director Bob Vallio discussed the threat to much of the High Frequency bands by the much-touted "Broadband Over Power Lines (BPL)" internet access plan. Vallio demonstrated that in test areas it appears the relaxation of power line radiation tolerances would just about wipe out any HF emergency contacts. He urges we join the effort to write our lawmakers to prevent it from happening.

On another front, Steve Miller, K6FDR is taking the Citizen's Emergency Response Team (CERT) course offered by Carla Glazebrook and her team of instructors from the Fresno Citizen's Corps. As many of you know, Kim, KF6ZSW and I also took the twenty hour course.

### FARC General Membership Meeting May 14, 2004

The meeting was called to order at 7:20 pm by the president, Kim/KF6ZSW. All present introduced themselves.

Vice-President Craig/K6QI asked for the floor and recognized the hard work of the Hamfest Committee.

Kim asked for Ted/K6FGE and Paul/W6VPS to be recognized for their work on modifying the club trailer. They had put in two to three full days work on it at that time. Dan Pruitt/KG6ALC and Steve Miller/K6FDR also aided their efforts.

A brief break was held at 7:30 so that members could look at the renovations on the trailer, which had been brought to the meeting. The meeting resumed at 7:48.

The board meeting minutes were presented. No comments were made as to content.

Treasurer Bob/KF6FIG gave his report, including details on Hamfest. A small profit was made. The report was approved by the members.

The Tech Committee-Chairman Rob/AE6GE, Co-Chairman Mark/K6ORJ, Kim/KF6ZSW, Gene/W7POR, and Jan/KG6SUL-gave a brief demo and talk about how repeaters work. Mark also explained about the recent changes in the club repeater. The Meadow Lakes repeater was disabled. On Thursday, May 13, the controller was pulled. The reason for this was that the club did not have the control codes for messages (such as Gene's spot promoting Hamfest), and the inability to turn the repeater off and on when necessary is in violation of FCC codes. FCC has in-

quired as to why the repeater had not been turned off when an unlicensed operator used the repeater.

Kim and Rob are negotiating with Ch. 30 to increase security, possibly by changing the locks on the building and installing a door inside. Other sites are being investigated; one possible site is on Deadwood.

The new repeater is located in Squaw Valley at a temporary site. The signal is weak in some areas, but Rob, the trustee, has the codes and can control it. The PL is on automatically but can be turned off temporarily through a series of touch tones. The 220/440/autopatch is down temporarily until the repeater finds a permanent location. Maps by Dave Smith/W6TE showing the repeater coverage area were available for view.

Future repeater plans: restore the 220/440 autopatch, clean up the audio squelch tail, and locate repeater in a more secure area.

Gene pointed out that NARC coordination plans for repeaters consider the use of a 10 watt mobile, not an HT, as a standard to operate the repeater. Some low power HTs may not be able to hit the repeater.

Rob and Kim have given Ch. 30 a proposal about leaving the repeater at Meadow Lakes and should get a response within a week or so. Ch. 30 is currently in budget meetings, but FARC is wanted at the site. It may take 2 weeks to 60 days to get the details negotiated. Better security benefits all who use the building (Ch. 30, KISS, KMJ, Infinity).

Gene said that historically Henry Broadcasting originally didn't want the repeater there because of concerns about its broadcast equipment. An agreement was worked out that meant the club has been unable to have legal and reasonable access to the equipment. FCC requires control of the repeater. Riley Hollingsworth sent a letter stating that the club is responsible should an unlicensed operator use the repeater, and it must be turned off. The unlicensed operator apparently has the ability to turn the repeater on and off. The repeater is owned by the club, but the board holds it in trust for the club.

The rent is \$1 per year at the Meadow Lakes site.

The board asked for alternative sites that were approximately equal to Meadow Lakes in coverage, which has an elevation of about 4400 feet. The Squaw Valley site is lower, with shadowy

hills in the footprint, and Bear Mountain is in the middle of it.

If Ch. 30/Disney agrees, the new repeater will be installed at Meadow Lakes. The board noted that Tulare County and Kern County radio clubs have had similar problems with repeater sites. Meadow Lakes is ideal for FARC because it is on an overlook which allows for great coverage.

Varouj/N6DBH asked how the whole change and issue came about. The board explained that the lack of access and control of the repeater has existed for awhile, but the letter from Hollingsworth pushed the issue. There has also been jamming as well, and a CW signal was sent using AC6WS/Lee's call, which would have been a false signal, since he did not send it. No one on the board has had ready access to the building and the repeater. Even Rob, the trustee, still had no access to the equipment.

This has been a six-month process of trying to find a solution, which finally came to either shutting the repeater down or moving it. There was even a threat of sabotage at Hamfest, so the new repeater was set up at Squaw Valley as a backup. Fortunately, Hamfest went well and there were no problems.

Gene gave a repeater demonstration and explanation of how it works. The repeater on display would be on loan to the FARECC trailer for local use. Gene emphasized that the OWNER is always responsible for repeater operations; The FCC historically supports owner policy for the use of a repeater. The repeater license W6TO is issued to the club, and the trustee (Rob) is responsible for its proper operation.

A break was taken from 8:30 to 8:40.

Craig wanted to delay the radio auction, as John/K6MI had stated that the radio was not known to be working. Craig will take it home and test it. There was some discussion as to whether to auction it as is, but Craig felt it best to test it first.

Committee reports were given. Hamfest went great, and planning is already underway for Hamfest 2005. Kim suggested

Exams for all Amateur license classes will be conducted on the following dates in Fresno, California. Exams are given on Sunday and Begin at 1:00 P.M.

- August 1
- November 7

**Location:** Seventh Day Adventist Central Church, 2980 East Yale, Fresno CA 93703. One block south of Clinton and one block west of First Street, southwest corner of Yale and Orchard. Watch for signs.

**Directions:** From Hwy 99, take Clinton Ave. exit east four miles to First St., turn right (South), one block right on Yale, one block. Look for Signs. From Highway 41, take Shields Ave exit, turn right (East), 1 mile to First St., turn right, continue one block past Clinton, right on Yale to Orchard. Look for Signs.

Theory Exams are multiple choice. Code Exam is fill in the blank. Express mail is used to send paperwork to ARRL, who sends data to FCC via electronic mail, thus assuring the fastest possible service on new licenses which typically arrive in about 2 weeks.

Letter from Keith Graves.

Friday, April 09, 2004

To The Board of Directors Fresno Amateur Radio Club

Reference: Rumors

Directors,

I would like to have the following issues addressed and answered by the Board of Directors in an effort to quell any unfounded rumors that seem to be persisting.

1. Board meetings are by the by-laws supposed to be open to the general membership. I have heard about people being told they could not attend a Board meeting since they were not board members.

2. Expenditures by the Board, which exceed a given amount, are supposed to be approved by the general membership, what is that amount supposed to be. I believe that the amount was \$250 before the general membership had to approve of it, but am I wrong.

3. I have gone back through my copies of Skip and not found any mention of any audits of the accounting practices of the club required by the articles of incorporation / and the IRS since the FARC has been granted non-profit status for tax filing.

4. I have heard many people during numerous conversations with many different members make the statement "oh no that doesn't apply anymore, the board changed the by-laws". I question the validity of their comments since the by-laws cannot be changed without the change going before the membership, the board cannot make such arbitrary changes.

5. I would also ask, since this is a non-profit organization, why does the board continue to charge exorbitant amounts to the club members, the general public etc. for items we as a club used to and still could absorb through all our fund raising events and dues.

-There was an anonymous letter sent to Fresno State University attempting to convince the University to not allow FARC to have Field Day or the Picnic at O'Neill park.

We will be meeting in the next few weeks with Channel 30 personnel to secure our continued access and use of the Meadow Lakes repeater site.

Ken Holden still has club property stored in the Channel 21 building.

The repeater has been plagued with jammers and we have received no help from the local OO's.

Field Day: Kim Davis reported everything is under control and there will be a planning meeting this month.

Fund Raising/Community Awareness:

Channel 18 is this Sunday. Sanger Farmers Market/Heroes night would like us back again this year. Grizzly Games; Craig and friend worked the first game.

Christmas Awards Dinner: Kim Davis reports that the membership want an awards banquet. We have worked out a deal with the Ramada Inn a banquet style dinner for \$20.00 a person.
